

## City of Lancaster

A Description of the Boundaries of the City as from the 1<sup>st</sup> April, 1935, as approved by the County of Lancaster Review Order, 1935, and shown on the deposited maps referred to in Section 8 of such Order and varied by the County of Lancaster (City of Lancaster) Confirmation Order, 1962.

Commencing at a Boundary Stone fixed at the south-easterly corner of the Lancaster Moor Hospital (formerly described as the County Mental Hospital) Annexe in Quernmore Road, and proceeding in a north-easterly, northerly, and westerly direction along the boundary wall of the Lancaster Moor Hospital to its junction with Moor Lane, the boundary runs in a northerly direction along Moor Lane to its junction with Ridge Lane and Grimeshaw Lane, thence in a northerly and north-westerly direction along a fence to the south-west of Dolphinlee Farm, thence in a westerly direction along a fence to the Lancaster Canal, thence in a north-westerly and north-easterly direction along the easterly side of the Lancaster Canal for a distance of about 200 yards near the Caton Road viaduct, crossing the canal at that point and proceeding along the southerly side of the canal across the Lune Aqueduct to the junction of the Township of Halton near Aqueduct Cottage, thence in a south-westerly direction along the northerly side of Green Lane to its junction with Slyne Road near Slynedales Lodge, crossing Slyne Road.

Then proceeding in a southerly direction to Hamerton Hall Lane, thence in a westerly direction along the northern side of Hammerton Hall Lane to its junction with Barley Cop Lane, thence in a northerly and westerly direction along the northerly side of Barley Cop Lane to its junction with Powder House Lane, crossing Powder House Lane and proceeding in a westerly direction along the northerly side of a road leading to Torrisholme Road at the foot of Cross Hill, thence in a southerly direction along Torrisholme Road to a point opposite the Water Meter Chamber of the Lune Valley Water Board, crossing Torrisholme Road to the south of the Meter Chamber.

Then proceeding in a southerly direction along the westerly boundary of Torrisholme Road to a point where an occupation road joins it, thence in a westerly, southerly and westerly direction along the easterly boundary of such occupation road to a point approximately half way to Morecambe Road, thence in a southerly direction in an imaginary line to Morecambe Road.

Then crossing Morecambe Road and proceeding in a southerly direction along a fence to the west of Scale Hall Farm, crossing the British Railways' Branch Line to Morecambe and Heysham to a point on Oxcliffe Road, thence in a south-westerly direction along Salt Ayre to the centre of the North Channel, thence along the centre of the North Channel across Salt Ayre and Oxcliffe Marsh to a point in the centre of the River Lune opposite Oxcliffe Hill Farm.

Then proceeding down the Centre of the River Lune in a southerly direction to a point opposite the northerly boundary of Ashton Park, thence in a northerly and easterly direction along the said boundary of Ashton Park to a point east of Waterside Farm, thence in a northerly direction to the occupation road leading to Waterside Farm.

Again proceeding in an easterly direction along the northerly side of the said occupation road to its junction with Ashton Road, crossing Ashton Road and proceeding in a northerly direction along the easterly side of Ashton Road to its junction with Carr Lane leading to Broken Back Bridge, proceeding in an easterly direction along the southerly side of Carr Lane and Broken Back Lane to a point beyond Whinney Carr Farm, thence in a southerly and easterly direction along the easterly side of Broken Back Lane to its junction with Burrow Beck, thence in an easterly direction along the northerly bank of the Burrow Beck to a point on the westerly side of the Main Road between Lancaster and Preston where the Main Road crosses Burrow Beck. The Boundary then runs in a southerly direction along the westerly side of the Main Road to a point opposite the northerly junction of the said Main Road and Green Lane thence along the northerly and westerly boundary of Green Lane to a point being the southern extremity of field No. 193, thence continuing north easterly along the westerly boundary of the Lane which leads to the Lancaster-Preston Motor-By-Pass to its junction with such By-Pass and then along the westerly boundary of the By-Pass to the southerly boundary of field Nos. 145 and 55. The boundary then runs along the southerly boundary of such fields to the south westerly boundary of field No. 145 with its junction with field No. 144 thence northerly and westerly along the boundary of fields Nos. 144 and 145 to the fence dividing field No. 143 from field No. 139, thence along the northerly boundary of field No. 138 to a fence dividing field No. 138 from field No. 151, thence to the northern point of the fence or hedge dividing field No. 151 from field No. 139, thence along the northern boundary of field No. 151 in a westerly direction to its north westerly junction with field No. 153 thence northerly along the boundary hedge between fields Nos. 153 and 152 to the south side of Bailrigg Lane then westerly along such lane to a point opposite a footpath leading to a footbridge and to Aikengill then across Bailrigg Lane and long the easterly side of such footpath to a point where the said footpath joins Burrow Beck to the east of Burrow Beck House thence in an easterly direction to a fence to the east of a public footpath leading from Hala Hill to Bailrigg Lane along the fence in a southerly direction for approximately 130 yards, thence in an easterly direction to the north-easterly corner of a small wood to the west of Bailrigg Reservoir, thence in a northerly direction along the fence to a point on the public highway near Glen Tarn, crossing the highway and proceeding in a northerly and easterly direction to the north-west corner of the boundary of Glen Tarn.

Then in a westerly and northerly direction in an imaginary line taken 150 feet to the east of Bowerham Road, along the easterly boundary of Burton's Farm, and Woodside, thence in a northerly and easterly direction along the easterly boundary of Willow Wood and Newlands Farm, and thence in an imaginary line taken 150 feet to the south and east of Newlands Road, crossing Langthwaite Lane to a point on the boundary of the Lunesdale Rural District, thence along such boundary in a westerly and northerly direction to the north-westerly side of Grab Lane at a point near Oatlands Farm, thence along the north-westerly side of Grab Lane to the Boundary Stone at the south-easterly corner of Moor Lane being the point of commencement.
