**THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (Consolidation) ORDER 2023 (Amendment No 1) Order 2024**

Notice is hereby given that Lancaster City Council, subject to approval of Lancashire County Council and the Chief Officer of Police, and in exercise of its powers under sections 32, 33, 34 35, 35 (c), 39, 124 and Schedule 9 of the Road Traffic Regulation Act 1984, proposes to make the above-named Order.

The effect of the Order is to (1) Amend the City Council of Lancaster (Off Street Parking Places) (Consolidation) Order 2023's fees and charges, (2) Add Kingsway, Middle St & Wheatfield car parks to the Order, (3) Amend plan 31 Central Drive Morecambe, (4) Remove Friars Passage car park, (5) Permit classes amendments (6) make minor amendments to the Order.
