#### Reminder: Consultation on the schedule of Further Main Modifications on the Climate Emergency Review of the Local Plan closes soon.

The Planning Inspector confirmed in her letter of 30<sup>th</sup> January 2024 that a focussed **further main modifications consultation should take place in respect of amendments to Main Modifications MM14 and MM25** which respectively address energy efficiency standards within Policy DM30A and wind energy within Policy DM53 within Part Two Climate Emergency Review of the Development Management Development Plan Document.

This period of consultation concludes at 5pm on Friday 3 May 2024.

Once the consultation closes on 17 May 2024 we will start to narrow down the issues the local plan will focus on and investigate opportunities for how these matters can be addressed. All of this work will help us to put together a draft Local Plan for the district which will be subject to public consultation in due course. The draft plan will be an important stage of the process as it will, for the first time, identify land for development and set out emerging planning policies. In the meantime we will continue to engage with you as the content and direction of the plan begin to emerge. Over the course of this year we will be organising a range of consultation events, face-to-face and virtual to talk to all sections of the community.
