

a) General – all four licensing objectives (b,c,d,e)

The business has taken advice from the licensing authorities, the local police and a licensing solicitor, and has implemented a robust range of measures to ensure that licensing objectives are met. Existing management practices will continue to operate to promote the licensing objectives. We do not anticipate that the proposed removal of the aforementioned condition will adversely impact these objectives.

b) The prevention of crime and disorder

CCTV is in operation around the clock. Cash is removed from the premises each night; stock is removed to a locked room to deter theft/vandalism. A zero tolerance policy is in place re: disorderly behaviour and staff are trained to deal with potential incidents. The premises carries a log book for the recording of concerning incidents.

c) Public safety

The premises operates in accordance with legal health and safety requirements and has a health and safety policy in place with which staff are familiarised. Public spaces are monitored to mitigate overcrowding. Fire exits are clearly marked; smoke and carbon monoxide detectors are fitted; fire extinguishers are in place in case of emergency. Smoking is prohibited throughout the premises. We have staff trained in first aid and carry a first aid kit and incident book.

d) The prevention of public nuisance

The premises operates in accordance with local ordinances regarding noise, including those respecting waste disposal/ collection and goods delivery. The premises closes at 22:00 to reduce potential noise disturbance to neighbouring properties. Music is performed on weekend afternoons and noise levels are closely monitored by the premises supervisor and premises licence holder. Outdoor spaces are monitored regularly for excess noise and to ensure alcohol is consumed only within the bounds of the premises; signs are in place forbidding the consumption of alcohol beyond the bounds of the premises. We also have signs reminding customers to enter and exit the premises quietly to minimise potential nuisance to neighbours. Incidents pertaining to excessive noise are rare and staff are trained to deal with them swiftly and rigorously.

e) The protection of children from harm

The premises operates in accordance with the Challenge 25 policy. Staff are trained to monitor the consumption of alcohol and ensure that no person under the age of 18 consumes alcohol on the premises. Under 18s may not enter the premises without an adult. All concerning incidents are recording in the premises log book.

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
