(AMENDMENT NO 4) ORDER 2026

The City Council of Lancaster (hereinafter referred to as "the Council") pursuant to arrangements made under section 101 of the Local Government Act, 1972 with the County Council of Lancashire in exercise of its powers under Sections 1, 2, 32, 33, 34, 35, 35C, and Schedule 9 of the Road Traffic Regulation Act 1984(hereinafter called the "1984 Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and Section 43 and Schedules 3 and 6 to the Road Traffic Act 1991(hereinafter called the "1991 Act") hereby make the following order.

1. Commencement, Citation and Revocation

- 1.1 This Order shall come into operation on [] []2026 and may be cited as " THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (Consolidation) ORDER 2023 (AMENDMENT NO 4) ORDER 2026".

2. Interpretations

- 2.1 Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

- 2.2 In this order, except where the context otherwise, requires, the following expressions have the meanings hereby respectively assigned to them: -

2.2.1 "1984 Act" means the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991.

2.2.2 "Enactment" - means any enactment, whether public, general, or local and includes any order, bylaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

- 2.3 Any reference in this order to any enactment shall be construed as a reference to that enactment as amended or substituted by any subsequent enactment.

- 2.4 Any reference in this order to a masculine gender shall include reference to the feminine gender and neuter gender.

- 2.5 Any reference in this Order to a singular includes the plural.

- 2.6 The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

3. Amendments

- 3.1 THE CITY COUNCIL OF LANCASTER (OFF STREET PARKING PLACES) (Consolidation) ORDER 2023, the Principal Order, is hereby amended as follows:

- (1) At Part A, Article 1(4) of the Principal Order between "Business Permit" and "care at home service" there is added the following:

"Campervan" - means any and all LGV's however ever converted to being able to be slept within; including DVLA registered motorcaravans, DIY

adapted vehicles, stealth vans, body-on-frame campervans or another similar vehicle;

- (2) Part B, Article 2(11) is amended to include, the following immediately after the First Schedule "...except Coastal Road car park, Morecambe – Plan 8."
- (3) The First Schedule – Table 1 (**Annex 1**) to the Principal Order be amended to remove the authorisation of all permits in the Auction Mart Car Park, Lancaster (Plan No. 5).
- (4) The First Schedule – Table 1 (**Annex 1**) to the Principal Order be amended to amend the charging tariffs for use of Electric Vehicle Recharging in the Auction Mart Car Park (Plan No. 5). The charging tariff is as per The First Schedule Table 4 (**Annex 1**).
- (5) The First Schedule Table 1 (**Annex 1**) to the Principal Order be amended to designate all parking bays as Blue Badge only in Bulk Street Car Park, Lancaster (Plan No. 4). The authorisation of Specific 5-day permits is removed. Bulk Street Car Park, Lancaster (Plan No. 4) is replaced by the attached plan at (**Annex 2**)
- (6) The First Schedule Table 1 (**Annex 1**) to the Principal Order be amended to delete Nelson Street Car Park.
- (7) The First Schedule Table 1 (**Annex 1**) to the Principal Order is amended to permit campervan parking, maximum of 48 hours (no return within 24 hours) in Coastal Road Car Park Morecambe, to be restricted to the x2 marked campervan bays.
- (8) The Scale of Charges for Parking Ticket and hours of charging as set out in The First Schedule Table 1 to the Principal Order be amended as per **Annex 1**
- (9) The Scale of Charges for Permits as set out in The First Schedule Table 2 – Permit Charges to the Principal Order be amended as per **Annex 1**

The First Schedule to the Principal Order is hereby amended by the attached Amendment No 4 First Schedule 2026. (**Annex 1**)

The Prohibitions and Restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
